**QUALIFICATION AND EXPERIENCE**

**A. Essential Qualification –**

MBBS Degree or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register.

**B. Desirable Qualification –**

Post Graduate qualification, preferably MD in General medicine.

Candidates have to bring a set of self-attested photocopies of their academic and/or experience credentials along with the original certificates, an original Identity proof issued by Government and two passport size colour photographs on the day of interview.
2. All Qualification, Experience and Age Limit will be recognized as on 21/07/2022.
3. As an Institute of national importance, NITR strives to have a workforce which reflects an all-India character and hence candidates from all over the country are encouraged to apply.

5. Degree as referred above should have been awarded by a University/Institute recognized by Government of India.
