Sub: Vacancy Notice for filling up of Two (02) posts of consultants (Land Acquisition) - Re engagement of retired state Government officials in exigencies of service in projects where Land acquisition is involved.

Ref: Railway Board's letter No. E (NG)/1/2020/RC-4/2 (Pt.2) dated 22.02.2022 circulated under RBE No.23/2022)

In view of the exigencies of railway services, it has been decided for re-engagement of retired State Government officials from Revenue Departments on contract basis for work related to Survey, updation of land records, coordination with State Government agencies in railway projects where land acquisition is involved.

1. Railway Projects under Chief Administrative Officer/ Construction/ South Eastern Railway.
2. Railways and important railway Infrastructure projects over South Eastern Railway.
3. For filling up of (02) two posts of Consultant (Land Acquisition) on re-engagement basis. Applications are invited from experienced and motivated state Government officials, who have worked as RI / LAO/ Spl. LAO /Additional Tahsildar/Tahasildar/Assistant Collector/ Deputy Collector etc. in Government of Jharkhand, Odisha. The state Government officials with experience in land acquisition, land and survey work would be given preference.
4. The eligibility criteria, No. of post, job requirement, scale of pay, age criteria etc. is furnished at **Annexure-I**. Eligible and interested officials may apply as per the application format at **Annexure-II**. The duly filled application should be sent to "The Sr. Personnel Officer (Con), Office of the Chief Administrative Officer (Con), South Eastern Railway, 11, Garden Reach Road, Kolkata-700043 in an envelope. The envelope should be superscribed with "Application for the Post of Consultant (Land Acquisition) In South Eastern Railway.
5. The candidates will be screened by a Selection Committee and their suitability will be adjudged keeping in view the job requirements, service particulars/relevant work experience etc.
6.
 - i) A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The Amount of remuneration so fixed shall remain unchanged for the term of contract.
 - ii) No increment, Dearness Allowance and HRA shall be allowed during the term of contract.

- iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
- iv) The amount so fixed shall remain unchanged during the term of appointment. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.

7. TERMS AND CONDITIONS:

- i) Suitability/competency of the staff shall be adjudged before such re-engagement.
- ii) Maximum age limit for such re-engagement shall be 65 years.
- iii) The integrity aspect will be checked while permitting such re-engagement.
- iv) Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service.
- v) No such re-engaged staff will continue in service beyond 65 years of age in terms of extant rules.
- vi) The employees who were removed/dismissed or compulsorily retired as a result of Disciplinary action are not eligible for re-engagement.
- vii) The re-engaged officials will not be eligible for any kind of leave (like CL., RH, LAP, sick leave etc.).
- viii) The re-engaged retired official shall sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.
- ix) Initially re-engagement of candidates will be made on temporary basis for a period of six months and their service may be extended as per requirement subject to performance found satisfactory.
- x) Service of the Consultants will be renewed monthly basis as per their performance report.
- xi) The re-engagement can be terminated any time as per discretion of the competent authority without any further notice / explanation or any ~~reason~~ thereof.
