Applications are invited (as per format enclosed) from interested retired Government servants not above the age of 65 years and are physically fit having computer skill and knowledge in establishment work for engagement as OSD in the office of the District Audit Officer, LFA, Sambalpur in the ministerial cadre for a period of one year from the date of his/her joining. The details of the application format, criteria, remuneration, terms & conditions of the posts are mentioned as detailed below. The filled in application should be addressed to the District Audit Officer, LFA, Sambalpur and should reach the office of the undersigned on or before **20.05.2023**. Application(s) received thereafter shall not be entertained.

- 1) The engagement shall be made for a period of 1 year from the date of his/her joining.
- 2) The appointee has to discharge such duties and in such a manner, as may be prescribed by District Audit Officer, LFA, Sambalpur from time to time.
- 3) The retired Govt. Servant against whom a Vigilance Case or Departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to five year preceding his/her retirement or is a member of a political party will not be considered eligible for re-engagement.
- 4) The selection will be governed by the procedure and rule laid down in GA & PG Resolution No. 23750/Gen. Dated 27.08.2014.
- 5) Consolidated remuneration of the employee shall be fixed as per Finance Department Office Memorandum No. 24533/F dated 29.09.2022.
- 6) Interested retired Govt. Servants fulfilling the criteria as envisaged in the above said resolution may apply with his/her full bio-data, one attested passport size photograph, history of services with an undertaking that no vigilance case or departmental proceeding or criminal prosecution is contemplated or pending against him/her or he/she has not been penalized for misconduct during service by registered post so as to reach the undersigned by date **20.05.2023**.
- 7) The engagement may be terminated at any time by the Appointing Authority, Sambalpur for unsatisfactory performance, on notice of one month and in case of any misconduct including, but not limited to, misappropriation, negligence or causing loss to Government, without any prior notice.
