(\*)Age Relaxation and Additional Weightage of Marks applicable for the eligible applicants who are employees of the OSH&FW Society.

1. To avail the benefit of age relaxation and weightage, employee concerned should have completed at least three terms of contractual services (11 Months each) under the OSH&FW Society.
2. The remarks recorded in PAR of the employee concerned must be "Outstanding "or "Very Good" for the preceding 03 (three) terms of contractual services under the OSH&FW Society.

3. The age relaxation for the applied post in respect of the employee of the OHS&FW Society shall be allowed @ 1 year for each contractual term of service in the society up to a maximum of 10 years, over and above the maximum age limit prescribed in the Advertisement for the said post, subject to an upper age ceiling of 55 years.
4. Candidate who is an employee of the OSH&FW Society and has cleared all the steps in the recruitment process up to the final level of selection shall be eligible for award of grace marks to the extent of 01 percentage of the total marks of examinations for each completed term of services in the society up to a maximum of 10 percentage of the total marks which shall be added to the total marks secured by the said employee.
5. All the above provisions shall also be application for only one member of the family of a deceased employee of the OSH&FW Society, if eligible as would have been applicable to the employee concerned.

#### **General information and Instructions:-**

- I. The above position is purely temporary and co-terminus with the scheme. Canvassing in any form will render the candidate disqualified for the position.
- II. Candidates, who are already working in Health Department either on regular or on contractual basis, have to produce No Objection Certificate from the employer (appointing authority) at the time of walk-in-interview. NOC issued by any of the authority other than appointing authority will not be accepted. NOC must be specific for the post, s/he applying and must be issued subsequent to issue of the advertisement.
- III. Interested candidates fulfilling the eligibility criteria are to attend the walk in-interview on **11.08.2023 at 11.00 A.M in the Office Chamber of the Superintendent**, MKCG Medical College Hospital, Berhampur with all relevant documents in original.
- IV. The candidate has to exhibit requisite document/ experience certificate which shall clearly establish his/ her eligibility as per conditions as above, without which his/her candidature shall be rejected. The experience certificate of the Employer must clearly specify the period of incumbency, name of the post and nature of responsibility.
- V. Candidates who are over aged, under qualified, not having requisite experience etc. his/her candidature shall be rejected.
- VI. Non production of required documents in original shall be liable for rejection.
- VII. If any candidate is found to have suppressed any material information or furnished false information / documents, his/her case shall not be considered for the post and in case already engaged on the basis of the said information/ documents his/her service shall be terminated from the society forthwith. Candidates who have been disengaged earlier from the OSH&FW Society on administrative ground such as disobedience/ poor performance/ misbehaviour / criminal activity etc. are not eligible to apply.



IX. The authority reserves the right to modify or cancel the recruitment criteria at any stage of recruitment process without assigning any reason thereof.
