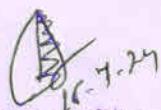

Applications are invited through **registered/Speed post** from the eligible candidate for recruitment of 1 no. of Aspirational Block Fellow in Paikmal Block of Bargarh District under Aspirational Block Programme NITI Aayog, Govt. of India. The application should be reach with a sealed envelope superscribed with "**APPLICATION FOR THE POST OF ASPIRATIONAL BLOCK FELLOW**" on or before **30.07.2024, 05 .00 PM** to the **office of the Deputy Director (P&S), DPMU, Bargarh, Odisha-768028**. The application in the prescribed format should contain self attested photo copy of all the educational qualification, Caste Certificate, Residence Certificate, Work experience along with two nos. of recent passport size photo (**Ref: Annexure-A**). **The selection process of candidate shall be shortlisted based on Career Assessment and Interview/Viva-voce.** For Further details visit www.bargarh.odisha.gov.in.

Objectives:

3. Strengthen monitoring and evaluation mechanisms to track progress effectively.
4. Foster greater community engagement and participation in developmental initiatives.
5. Empower local stakeholders with knowledge, skills and capacity building.

General criteria of Eligibility:

Candidate applying for the above post should be-

- A citizen of India.
- Of good character.
- Of sound health, good physique and free from organic defects of bodily infirmity
- If married, must not have more than one spouse living
- Must be able to read, write and speak Odia fluently and:-
 - i. Must have passed Middle School Examination with Odia as language subject or
 - ii. Must have passed Matriculation or equivalent examination with Odia as medium of examination in non language subject or
 - iii. Must have passed in Odia as language subject in the final examination of Class VII or above from a school or educational institution recognized by Govt. of Odisha or the Central Govt. or
 - iv. Must have passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department, Govt. of Odisha.

I. Qualifications:

- 1) Post Graduate with First Class in any discipline from a reputed institution
- 2) Should possess data analysis and presentation skills
- 3) Should be conversant with use of social media
- 4) Should possess Project management Skills
- 5) Experience of working/internship with a Developmental organization
- 6) Self-driven with good communication skills
- 7) Knowing the local language of the respective Aspirational Block is a requirement for all Aspirational Blocks fellows.
- 8) PGDCA/DCA (Knowledge of Basic Computer Skill)

Note: Preference will be given to

- i. The Local Candidate of Bargarh district preferably nearby Paikmal Block.
- ii. Those who have completed their higher education in the development/rural stream.

II. Age:

However, the upper age limit is relaxable 5 years for candidates belonging to SC/ST/SEBC category and all women candidates and 10 years for candidates belonging PwD category & the total period of service rendered in defence service in case of Ex-serviceman.

III. Tenure of Aspirational Block fellows.

The tenure of Aspirational Block Fellow will initially span for one year or as desired by NITI Aayog, during which they will engage with Block level Officials to drive developmental initiatives and empower local communities. Recognizing the potential for sustained impact, the program allows for a one-year extension of the fellowship, contingent upon the fellow's satisfactory performance and demonstrated contributions to the program's objectives as determined by the State Governments.

IV. Compensation:

Each fellow will receive a monthly stipend of **Rs. 55,000/-** as a token of appreciation for dedicated service and valuable contributions to the Aspirational Blocks Programme. This compensation package also includes provisions for travel allowances to a maximum of **Rs. 5000** per month and other necessary support to ensure that the fellows can effectively immerse themselves in their assigned Block and focus on fostering change and progress in Blocks.

V. Process of Selection:

The selection of candidate shall be made among the shortlisted candidate on proportion of post in 1:7 ratio or less as per the availability of candidates observing following procedure.

The total mark will be 100. Out of 100 marks, 70 marks will be assigned for shortlisting the eligible candidates in following manner:

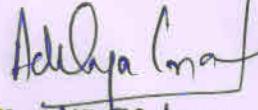

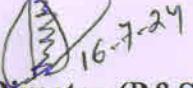
