**REQUIREMENT OF GENERAL MANAGER/ INSPECTION FOR DMRC PROJECT AT  
SRICITY, NEAR CHENNAI, ON DEPUTATION/ POST RETIREMENT CONTRACTUAL  
ENGAGEMENT (PRCE) BASIS**

The Delhi Metro Rail Corporation (DMRC) Ltd., a Joint Venture company with equal equity participation from the Govt. of India and the Govt. of the National Capital Territory of Delhi, has been entrusted with the responsibility of implementation of the rail-based Mass Rapid Transit System, for Delhi. The Delhi Metro Rail Corporation, the Life line of Delhi, prides itself on its ability to nurture its employees through its unique work culture. DMRC is empowered by about 14,000 employees, with MRTS activities spread over Delhi/NCR, and other cities in India and abroad. The average passenger journey per day in Delhi/NCR is about 61 Lakhs. In addition to the above, DMRC is involved in providing consultancy services to a number of cities within India and abroad.

To meet with the immediate requirement for DMRC projects for filling up of the following position of General Manager (Inspection) on Deputation / Post Retirement Contractual Engagement (PRCE) basis to carryout Inspection, Testing & Commissioning of 'RS-17' Rolling Stock at Sricity (near Chennai), applications are invited from experienced, dynamic and motivated candidates, currently working in, or, retired from the Indian Railways/ Govt. Organizations/ PSUs/ Metro sectors. Candidate should possess technical expertise in the field of inspection of manufacturing of Railway/ Metro coaches. The details of the position are as under:

#Candidates selected on Post Retirement Contractual Engagement Basis shall be paid Consolidated Fee, as indicated above. The emoluments are in terms of the extant rules of DMRC. Candidates must be working in/ retired from the functional grade, on regular basis. MACP will not be considered.

**2. WORK EXPERIENCE ELIGIBILITY CRITERIA (as on 01/03/2025):**

A. ) The officer should have a total of 18 Years' service at Gazetted/ Executive level Minimum 10 Years experience in the field of inspection of manufacturing of Railways/ Metro Coaches. The officer should also be conversant with functioning in a computerized environment. Candidate should be free from D&AR and Vigilance angle.

The candidate who are in regular service in Railways/ PSUs/Metro's at present, will also be considered eligible provided they opt for retirement from the services through VRS or otherwise before joining DMRC.

**B.) Pay Scale Eligibility Criteria:**

**i) For candidate's applying on deputation basis-**

Officers working in the CDA pay scale of Level 14 (Rs. 144200 – 218200), in the pay matrix as per the 7th CPC, in any Govt. Organization/ PSUs, including services put in on deputation, in the above pay scale, with a total of 18 years' service at Gazetted / Executive level in Govt/ PSUs and Minimum 10 years' experience in the field of inspection of manufacturing of Railway/ Metro Coaches.

OR,

Officers working in the IDA pay scale of Rs. 120000-280000/-, in any Govt. organization/ PSUs/Metro's, including services put in on deputation, in the above pay scale, with a total of 18 years' service at Gazetted / Executive level in Govt./ PSUs/Metro's and Minimum 10 years' experience in the field of inspection of manufacturing of Railway/ Metro Coaches.

**ii) For candidate's applying on Post Retirement Contractual Engagement (PRCE) basis-**

Officers working in or retired from the CDA pay scale of Level 14 (Rs. 144200 – 218200) or higher, in the pay matrix as per the 7th CPC, in any Govt. Organization/ PSUs, including services put in on deputation, in the above pay scale, with a total of 18 years' service at Gazetted / Executive level in Govt/ PSUs and Minimum 10 years' experience in the field of inspection of manufacturing of Railway/ Metro Coaches. Officers working in/ retired from non- functional grade at Level-14 may also apply.

OR,

Officers working in, or, retired from the IDA pay scale of Rs. 120000-280000/- or higher, in any Govt. organization/ PSUs/Metro's, including services put in on deputation, in the above pay scale, with a total of 18 years' service at Gazetted / Executive level in Govt./PSUs and Minimum 10 years' experience in the field of inspection of manufacturing of Railway/ Metro Coaches.

**3. JOB DESCRIPTION:**

The incumbent for the post shall be responsible for all inspection of manufacturing of Railway / Metro coaches.

**4. JOB LOCATION/ PLACE OF POSTING**

The incumbent for the post shall initially be posted at Sricity, near Chennai. However, the selected candidates shall be liable to be posted/ transferred to any of the offices/ Project sites under the control of the corporation in India, or, abroad.

**5. TERMS OF ENGAGEMENT**

- a) The engagement of post-retirement contractual basis, initially shall be for a period of one year. The term on contract may be extended further, subject to the requirement of the corporation on the basis of the satisfactory performance.
- b) For engagement on deputation basis, normal tenure of deputation is 05 years, which may be extended further to 07 years in special cases, or, till the date of superannuation whichever is earlier.

**6. PAY AND EMOLUMENTS:**

**i) For candidate selected on PRCE Basis-** The selected candidate shall be eligible for a consolidated salary @ Rs. 182,500/- per month#.

The selected candidate for the position of shall be eligible for consolidated remuneration as mentioned above, HRA/lease facility and other benefits as per the company policy.

#The emoluments are in terms of the extant rules of DMRC. The remuneration shall be based on the last substantive grade, subject to a maximum amount as indicated above.

The consolidated fee for candidates working in / retired from, at higher Grade, shall be restricted to the consolidated salary as mentioned above.

ii) **For candidate selected on Deputation basis**—The selected candidate shall continue to draw parent department pay plus deputation allowance, as applicable, under the Govt. of India rules.

## **7. SCREENING PROCESS:**

The selection methodology for candidates applying on Deputation and PRCE basis shall comprise of **Personal Interview**.

For the purpose of grant of medical benefits, as applicable, the engagee shall have to undergo a Medical Fitness Examination, in case of the candidate applying on PRCE basis.

**(The Medical Examination will be in Executive/Technical category. The details of medical examination are available on the DMRC website).**

The selection process would judge different facets of knowledge, skills, comprehension, aptitude and physical fitness. Candidates would have to qualify the Screening Process, before being adjudged as suitable for selection. **All related information shall be available only on Website: <http://www.delhimetrorail.com> and candidates must regularly check the website for updates.**

## **8. SCHEDULE OF SELECTION:**

- i. Last date of receipt of duly filled in application (along with relevant documents) through Speed post, OR, email is **16/04/2025**. Incomplete applications, or, applications received after the due date, shall be summarily rejected. DMRC shall not be responsible for loss /delay in post.
- ii. **The list of shortlisted candidates shall be uploaded on DMRC website in the Fourth week of April, 2025 (tentatively) and interview shall be held in the First week of May, 2025 through online mode (tentatively) (complete details shall be displayed on DMRC website).**
- iii. No separate communication, by post, shall be sent to the candidates individually. Candidates are advised to go through the instructions/ schedule for the interview displayed on DMRC website and appear for the interview, accordingly, along with the original copies of the testimonials.
- iv. **The final result will be declared by Second week of May, 2025. (Tentatively).**

Eligible and willing candidates for the aforesaid post may apply as per the application format at **Annexure-I**. The candidate must enclose all relevant proof /documents in support of qualification, experience, pay and pay scale.

The candidates presently employed in the Central Govt./ Govt. organizations, or, the Public-Sector Undertakings (PSUs) should send their application through proper channel, along with the copies of APARs for the last five years, Vigilance and D&AR clearance, so as to reach the under mentioned address / email id, by the stipulated date. The applications received after the due date shall be summarily rejected.
