1. The Candidates must be an Indian Citizen as defined under Articles 5 to 8 of the Constitution of India.
2. The Candidate must not be less than 18 years and not more than 40 years of age as on 01/01/2025. The upper Age limit is relaxable as per Govt. Rule.
3. Minimum Educational Qualification is Class VIII passed and those who have passed H.S. examination shall not be eligible to apply for the post.
4. The candidates must have valid Professional/Transport Driving License.
5. If any Candidate is found to have suppressed his/her educational qualification or given any wrong information at the time of applying for the post, his/her candidature shall be liable to be rejected.

*6. The last date of receipt of application is **02/05/2025**. Incomplete applications and applications received after due date shall be summarily rejected.*

7. The Candidates have to submit their application along with self attested documents(in photocopy) in a sealed envelope by **Courier/Registered Post/Speed post/ or deposit** the same in the '**Drop Box**' provided for the purpose in the premises of the District & Sessions Judge's Court Building at Nagaon.
8. Contact Numbers and e-mail ID (if any) of the applicants should be provided in the application.
9. The application should be addressed to the District & Sessions Judge, Nagaon and the applicant must mention on the envelope containing the application "**APPLICATION FOR THE POST OF DRIVER/DRIVER (CONTRACTUAL)**", as the case may be, at the top.
10. The applicant will have to submit self attested relevant testimonials (Photocopy) i.e. Educational Qualification Certificates & Marksheets, Driving License, Age Proof Certificate, Employment Exchange Registration Certificate and Caste Certificate (in case of Reserved category candidates) along with 3 copies of recent Passport size Photographs.
11. The eligible candidates shall have to appear for Skill Test (Driving) followed by Written/Viva-Voce Test and they will have to bring all the required original testimonials to appear Viva-Voce test.
12. The Candidates who are already in the Government Service should apply through proper channel.
13. Newly Appointed candidate, except Driver (Contractual), has to submit an undertaking that they will abide by the **NEW PENSION RULES**.
14. Newly Appointed candidates have to submit a declaration that "I and my family members are neither beneficiaries of the **Orunudoi Scheme** or have voluntarily opted out as on the date of appointment/engagement".
