Sub: Engagement of Part time Homeopath Practitioner under AYUSH at Jagjivan Ram Hospital, Mumbai Central under the aegis of Staff Benefit Fund of Western Railway.

Applications are invited for engagement of part-time Medical Practitioners in the following system of Indigenous Medicine on honorarium of Rs 37, 500/- per month without any other allowance, on the under mentioned terms and conditions:

Terms and conditions:

- 1) The Practitioners will be engaged by Staff Benefit Fund of Western Railway, hence he/she will not be considered as a Railway employee.
- 2) His/her engagement will be purely on temporary basis.
- 3) His/her service is terminable as per Railway SBF Rule on one month notice on either side of on completion of contract period without notice.
- 4) The engagement of the Practitioners will be for a term not exceeding one year at a time subject to review at the end of the term based on the output, not extendable beyond 12 terms or till the age of attaining 70 years. However, the Railway Administration shall reserve the right to enter into the fresh contract with the Practitioner.
- 5) The service of practitioners will be discontinued automatically on attaining the compulsory age of 70 years.
- 6) The engaged Practitioners will attend the dispensary for 4 hours daily on all working days of the week except the days on which the office will remain closed.
- 7) Timing will be decided in consultation with local Staff Benefit Fund Committee & Chief Medical Director.
- 8) The Practitioners will be given working facilities in one of the rooms at Jagjivan Ram Hospital, Mumbai Central for which necessary equipment/furniture and materials will be supplied by the Railway. Also, Rs. 12000/- per month will be paid as a Subsidy of medicine.
- 9) He/she will be responsible for proper maintenance of equipment furniture and material given in his/her custody.

- 10) The Practitioners will maintain a record of patients treated and submit the same to Dy.CPO(Welfare & Bills), Churchgate, every month.
- 11) The Practitioners will submit a monthly statement of the expenditure towards the medicines used and will submit indents of requirements well in advance.
- 12) The Practitioners will issue no certificate for any purpose whatsoever.
- 13) The Practitioners will be entitled for 8 days leave & 02 RH in a year on full payment of honorarium out of which not more than 4 days leave will be allowed to be availed at a stretch. Any period of absence above this limit will be proportionately adjusted against his/her monthly honorarium. The leave sanctioning authority will be Dy CPO(Welfare & Bills), W. Rly HQ, office, Churchgate.
- 14) The Practitioners will only attend the patients at the AYUSH dispensary.
- 15) No Railway residential accommodation will be provided to the Practitioners.
- 16) No passes/PTOs or other fringe benefits as available to other Railway employees will be allowed.
- 17) The Practitioners will dispense the medicines without the help of an additional hand.

- 19) Retired railway employees are not eligible for the post.
